THE MAJOR PLANNING APPLICATION FOR 116 HOUSES IN HOOKWOOD

The 446 home planning application for Hookwood Greenbelt was refused by MVDC in 2023 but this decision was 'appealed' by the applicant and unfortunately the appeal was 'allowed' by the Government Inspector earlier this year. The Parish Council participated during the entire hearing and many residents gave passionate and heartfelt statements on the opening day. The Parish Council were unable to present new evidence from 18th March, due to being threatened with significant legal costs by the applicant.

The Parish Council understand how much pressure this situation has been putting on residents and we remain here to support you.

A last minute appeal for the Povey Cross location seems to have been withdrawn. A new application has just been published for 126 homes has just been lodged. Application reference MO/2024/1264 on MVDC's web site.

This 2^{nd} location has additional reasons as to why it is not a suitable location for building:

- Flood risk, particularly when associated with culverting a river
- Highways issues, the single entry point would be at Rivoli
- Protected species and Proximity to ancient woodland

CAR PARK CONSULTATION

The original *car park* application for Charlwood was refused planning permission by MVDC. Please take part in the new consultation and have your say over what you would like to see. If approved, the Parish Council will start working on the finer details of the installation. The consultation will start on 1st September and run for 6 weeks. You can complete the paper version or go on-line. The Parish Council will accept 1 entry per adult resident across the Parish.

GATWICK EXPANSION HEARINGS CONCLUDE

The huge amount of airport noise experienced by residents in Hookwood on 28th August marked the passing of the final deadline for comments on the 'Development Consent Order' was 27th August. If the 5 Government Inspectors decide they have received all the information they need in order to make their decision, they will have 3 months to consider, and put their recommendations to the Secretary of State, who will then have a further 3 months to make their decision.

- There have been 10 sitting days of 'Issue Specific Hearings' (ISH)
- 'open Floor' sessions where any person or organisation was able to make a statement either written, in person or in an on line statement
- Numerous rounds of questions from the Inspectors to various parties

The Parish Council has attended all but 1 of the ISH meetings, discussing topics such as noise, air quality and construction period, responded to many questions and requested an improved noise insulation and relocation package and a significant mitigation fund specifically for our community. CLEARING OUR PAVEMENTS

We want to be able to leave our cars behind for shorter journeys, but none of us want to use a pavement if it means we arrive at our destination with scratches on our arms or muddy shoes. To bring them back up to use, the Parish Council are exploring having all our pavements cleaned and scraped back to their original width this winter.

Keeping ditches cleared and hedges cut back and not overhanging pavements or blocking public footpaths is householder responsibility. Please help us by having any overhanging hedges cut right back in October/November. If you will struggle to get this done, please contact us.
